- The Clerk's Office will be operating out of its current Olympic Towers address up to and including Thursday, October 11, 2018. **On Friday, October 12, 2018, the Clerk's Office will be open out of the Jackson Courthouse, on the second floor.** Our business hours remain the same – 8:00 a.m. until 4:30 p.m., Monday through Friday, except for federal holidays. Please see the attachment for our new mailing address.
- **Court proceedings for Hon. Carl L. Bucki and Hon. Michael J. Kaplan will be held in the Jackson Courthouse starting on Monday, October 15, 2018.** Courtrooms will be located on the **fifth floor**. Notices of hearing should include the proper location information, found on the attachment to this notice.
- Telephone numbers for Chambers and for the Clerk's Office will remain the same.
- Meetings of creditors (341 meetings) for Chapter 13 cases only will be held in the Jackson Courthouse **starting the week of October 15, 2018**, and will be held on the **fifth floor**. **NOTE:** 341 meetings for all other chapters will continue to be held in Olympic Towers.
- Locations for Batavia, Mayville, Niagara Falls, and Olean remain the same – the out-of-town locations are not affected by the move to the Jackson Courthouse.
